2023 EMPLOYMENT LAWS EFFECTIVE JANUARY 1, 2023

California has published a number of new laws effective January 1, 2023. Below are the new employment laws. Over the next several weeks, we will be posting more helpful information and laws that may impact your business. SB 1162

SB 1162 requires employers to make pay scale information available to job applicants and employees, and expands California's pay data reporting requirements.

AB257

AB 257 will create the Fast Food Council within the Department of Industrial Relations, composed of 10 members to be appointed by the governor, the speaker of the Assembly and the Senate Rules Committee. This council will work to establish minimum wages, working hours and other working conditions for fast food restaurants. Read more at: legislature.ca.gov

SB951

SB 951 extends the current wage replacement rates for California's

Paid Family Leave (PFL) and State Disability Insurance (SDI) programs, which were scheduled to sunset at the end of 2023, and sets up an increase in PFL and SDI rates beginning in 2025.

AB 1041

California expands who an employee can care for under both the California Family Rights Act (CFRA) and California's paid sick leave law, the Healthy Workplaces, Healthy Families Act (HWHFA). Read more at: legislature.ca.gov

AB2693

AB 2693 made changes to the state's COVID-19 notice requirements. The 2020 law required employers to provide notice to their employees when there's a potential COVID-19 exposure at the worksite and report cases to local health departments under certain conditions. Read more at: legislature.ca.gov

FOCUS ON FITNESS: A HEALTHY CONVERSATION WITH MY PEAK FITNESS OWNER, VINCE HALL

Winter is upon us. What does that mean for your fitness program? The days are getting shorter and colder and it's tempting to be lazy, skip exercise and stay inside curled up with a good book or movie. Add to that, the delicious treats and drinks that come with Holiday gatherings that beckon us to indulge. So how do all these temptations play into our fitness goals? Do we give up for the Winter with a plan to hit it hard again in the Spring? Or do we find creative ways to continue to meet our fitness goals and stay on a healthy and consistent track?

We posed these questions to Vince Hall, owner of My Peak Fitness and a personal trainer who has been providing fitness training and motivation to our community for many years. Vince shared with us some tips to stay motivated and on track during the upcoming Winter months.

Q: Vince, during wintry weather and the holiday season, is it okay to slow down or stop your exercise program for the season?

A: With cold weather it is harder for your body to get mobile and have mobility, as well as maintain that mobility. So, the direct answer is no, you should not slow down or stop. What most people should do is spend more time warming up the body before they use the treadmill, walk outside or whatever form of exercise they do. This will minimize the chance of "tweaking" a muscle which will really slow you down.

Q: What kinds of indoor exercises do you suggest replacing outdoor exercises on days it is too cold to be outside?

A: What most people fail to realize is that dynamic stretching is exercising. If you were to start your Apple Watch or FitBit or whatever tracker you use when you start dynamic stretching, you would see that you're burning calories. A few of my favorite exercises to do are marching in place, leg swings, countertop push-ups. Marching in place can be done



either seated or standing. After marching, move to leg swings. Leg swings are done by standing with your legs about hip width apart, placing your hands on the back of a chair or countertop and swinging your legs sideways or laterally, alternating legs for 30 to 60 seconds. The next exercise is countertop or wall pushups. Please remember to limit your range of motion on the depth of your pushups. Start small and work your way deeper in your range of motion as you get stronger. And last, do some stand up and sit downs in your chair, ten times. You can use your hands in the beginning until you get stronger and are able to do so without using your hands. Always start your routine with a good long stretching session and then add these three movements.

Q: If you don't belong to a gym or own weights, are there other things you can use to provide resistance or weight to exercise?

A: So, when you use weights, the technical term is "weight load." What things have weight loads in your house? Canned goods, bottles of liquids, or some of those nicelooking decor items on your coffee table. Just be sure that if you use anything that is glass, have a good grip so as not to drop it. Safety, Safety, Safety!

Q: Of course, we are all worried about growing older and maintaining an active life. How does exercise help us to stay young?

A: Great question! Studies have shown that exercise adds seven additional "QUALITY" years to your life, the important word there is quality. One of the keys to staying healthy when we get older is to keep your body fluids flowing throughout your system. The more stationary you are the less your fluids move. So just by moving your body, seated marching, standing up and down, active stretching, it keeps your body fluids moving and you feeling healthier and younger.

Q: And for those of us who aren't quite as young as we used to be, what exercises would you suggest to keep limber and active?

A: Keep this in mind, you do not have to do burpees or some of these dynamic crazy exercises that you see on TV, or at the gym, in order stay limber and active. Some of my favorite exercises for those of you that aren't quite as young as you used to be are leg swings and marching in place, make sure to use your arms while marching. You can also do countertop or wall pushups, making sure you

use your arms while marching. You can also do countertop or wall pushups, making sure you modify how far you go down. Standing up and sitting down from wherever you are, such as the couch, kitchen table or wherever. Another great exercise is arm circles. Turn your palms forward so they are facing in front of you and rotate the circles towards the thumbs, then turn your palms so they are facing behind you and again rotate the circles towards the thumb which will be the opposite circular direction.

Q: Living in the fast-paced Bay Area we have so many stresses in our daily lives. What does stress do to our health and how does exercise help us to cope?

A: Stress has a waaaaaaay bigger impact on your body than most people realize. Not only how you feel in that body but how fast your body improves visually. Stress will cause you to lose energy. This has a significant impact on your desire to actually want to workout. Stress also causes inflammation in the body. If you think about it, anytime you are injured, what is one of the first thing doctors try to do? Manage the inflammation. Decreasing and managing inflammation is one of the most important things you can do to keep your body healthy. One particularly good, quick way to help, is air boxing. Stand with both feet even, knees slightly bent and mimic hitting a boxing bag. Try to air punch for 30 seconds straight, then move to 45 seconds and work up to 60 seconds. This is a great way to work the stress out of your body.



Q: If someone says to you, I just don't have the time to exercise, what would you suggest as activities that are impactful, yet not time consuming?

A: This is something I hear all too often and I do not take it lightly as people are very busy trying to survive these days. There are, however, a couple of things you can do that will not impede upon your time. I know many of you drink coffee or tea in the morning, while you're waiting for those to brew, do some countertop pushups, and remember you can always modify and do a small dip. It still has benefits, regardless of the depth of the dip. Do five to ten chair sits and stands while waiting. Arm circles and leg circles are additional great movements that you can do while going through your day. If you do them while you're waiting for your coffee, or watching TV etc., you can eventually build on that by finding additional ways to add exercise movements into your day without adding more time to do them.

Q: If you were to give just one piece of advice for good health, what would that advice be?

A: Start with doing things you like to do. There are many fads and exercise classes out there that are good, but maybe they are not for you. If you do not like them, the chances of you maintaining them are low. Find activities that you like to do, and this will help you to be consistent. Consistency is the most important thing you can do for your good health.



ASK AN EXPERT: GEORGE DUARTE

ANSWERS TO THE EAST BAY'S REAL ESTATE MARKET AND MORTGAGE RATE PUZZLING QUESTIONS

We are planning on buying a home soon, should we wait for the rates to go down?

Rates are already softening in the last week as the market sees inflation beginning to soften due to the Fed raising the Fed funds rate. Rates are expected to stay "high" at least through the spring and maybe summer 2023. Oil prices will be a big factor. When I bought my first home, the rate I got was 12.50%, but we bought anyway, because it made sense for us at that time in our lives. You can always refinance when the rates go back down.

How much have property values gone down and should we wait to buy until they bottom

According to the Bay East Associaion of Realtors statistics, the median sales price of homes in

Fremont from Oct 2021 to Oct 2022 has decreased only 5%, from \$1,510,000 to \$1,437,000. This figure can vary from neighborhood to neighborhood. Predicting how much further or how much longer prices will drop is not possible to do with any accuracy; and my crystal ball never worked properly. If you feel secure in your employment, stable in your personal circumstances and purchasing a home makes sense for you, then you should do it.

What if we purchase a home and the value falls below what we paid for it?

The real estate market is like the stock market, it doesn't always go up, it can go down also, so it is possible that may happen. Home ownership is a long term proposition that is a proven builder of family wealth over time. Stay Calm and Make the Payments. You have to live somewhere. If you are not making a mortgage payment, you are paying rent, and someone else's mortgage payment.

What should we do to prepare to purchase a home?

Pre purchase planning is very important. I suggest meeting with a seasoned mortgage broker to get "pre-qualified". This is an analysis of your total income, debts, cash available and credit history to determine how much of a loan you can qualify for and how much down payment you can make. Gather your documentation- 2021 W2's, Federal Tax returns (1040s), last 3 months of bank statements (all pages, even if blank) for checking, savings and

retirement accounts. You will also need your 2022 W2's when you get them in January. The more prepared you are, the smoother the process you will have.

What are the benefits of purchasing a home in a down market?

There are several that come to mind. One is that there is less competition with other buyers in the marketplace. Another is that the sellers who are selling are more motivated and may be willing to negotiate more on their price and terms; and may even be willing to help with credit for closing costs and for necessary repairs. Yet another benefit is that because property prices are lower, the property taxes you pay will be lower, too.

You may have heard the term "buy the dip" from the stock market, it can be applicable to the real estate market as well. Happy Hunting!

Most memberships aren't free, but your membership will essentially pay for itself. The fees are usually low and the benefits are equal to (or more than) the cost.



You can share successes, express concerns, and talk about your business challenges with other business owners in your area to find the answer you need. You'll also be able to help other businesses with their challenges. The chamber's mission is to support the businesses in your area or industry, so it will act as a voice with local government for your needs. The chamber gives you the power to help influence change for the businesses in your community. Marketing Opportunities - As a member of your chamber of commerce you'll get free promotion. Lots of people use their local chamber as a way to find products and services. That free promotion also increases your ability to market business to business because you will have access to the list of other business owner members. Your chamber of commerce may provide you with advertising opportunities on its website. It might also publish newsletters, maintain social media pages, and run publications. Some organizations even offer sponsorships or fundraisers for member businesses or the chamber itself. When you first become a member, your chamber can help to promote your business. It most likely has a larger following with greater reach and exposure than your small business you can take advantage of. Be sure to follow them on social media and share relevant posts on your own
